International Electro-Technical Commission Meeting

From February 23 to March 1, 2012, staff represented the NRC as part of the U.S. national delegation to meetings of the International Electro-technical Commission (IEC) Subcommittee 45a, "Instrumentation and Control of Nuclear Facilities," in support of international standards development. The IEC is the international standards body for standards in the areas of electrical, instrumentation and control and communications engineering topics. Key issues discussed at this meeting were coordination with the Institute of Electrical and Electronics Engineers (IEEE) for development of standards, particularly in the areas of equipment qualification and post accident monitoring; development of IEC standards in the areas of cyber security, design and qualification of isolation devices, and categorization of digital systems important to safety; linking IEC standards with International Atomic Energy Agency (IAEA) standards; and accounting for lessons learned from the Fukushima accident in IEC standards.

Co-sponsored Workshop on Treatment of Probabilistic Risk Assessment (PRA) Uncertainties

On February 29 and March 1, 2012, RES co-sponsored a workshop with the Electric Power Research Institute (EPRI) on the treatment of PRA uncertainties. The workshop brought together experts to gain a better understanding of sources of uncertainty, how they are manifested in the PRA, and their potential significance to PRA model and results. The workshop specifically addressed uncertainties associated with risk assessments for internal fires, seismic events, low power and shutdown conditions, and for the Level 2 portion of a PRA. A report is being written summarizing the findings from the workshop. It is envisioned that the findings from the workshop can be used to support risk-informed decision making and to identify and prioritize future work to be pursued either by the NRC or industry. Participant feedback was very positive.
