## Purpose

USEC Inc. (USEC) hereby submits to the U.S. Nuclear Regulatory Commission (NRC) an update to Nominated Reviewing Officials for the American Centrifuge Lead Cascade Facility and American Centrifuge Plant.

## **Background**
