Technical Support for Molybdenum-99

On February 29, 2012, as a result of a competitive GSA Schedule solicitation, NRC awarded two labor hour Blanket Purchase Agreements (BPAs) for technical support for the review of construction and operating licenses for two Molybdenum-99 production facilities, and up to eight operating reactor license renewals. The BPAs were awarded to Ecology and Environment, Inc. (E&E) of Arlington, VA, and Los Alamos Technical Associates, Inc. of Albuquerque, NM. The period of performance for both BPAs is February 29, 2012, to August 21, 2012, with three 1-year option periods. The total value for the E&E BPA is \$3,124,914, inclusive of all options, and the total value for the Los Alamos Technical Associates, Inc. BPA is \$3,776,185, inclusive of all options.

Revision of Fee Schedules; Fee Recovery for Fiscal Year 2012, Proposed Rule; 10 CFR Parts 170 and 171 (RIN 3150-AJ03; NRC-2011-0207)

On March 15, 2012, the NRC published in the *Federal Register* (77 FR 15530) a proposed rule to amend the licensing, inspection, and annual fees charged to its applicants and licensees. The proposed amendments are necessary to implement the Omnibus Budget Reconciliation Act of 1990 (OBRA-90), as amended, which requires the NRC to recover through fees approximately 90 percent of its budget authority in Fiscal Year (FY) 2012, not including amounts appropriated for Waste Incidental to Reprocessing (WIR), and amounts appropriated for generic homeland security activities. President Obama signed the Consolidated Appropriations Act of 2012 on December 23, 2011, giving the NRC a total appropriation of \$1,038,100 for FY 2012. The FY 2012 proposed fee rule, based on the FY 2012 appropriation, would require the NRC to recover fees of approximately \$909,500,000 from licensees. After accounting for billing adjustments, the total amount to be billed as fees is approximately \$901,000,000. Comments on the proposed rule are due by April 16, 2012.

Meeting with Swiss Federal Nuclear Safety Inspectorate

On March 12, 2012, staff from the Information and Records Services Division, the Office of International Programs, and the Office of the General Counsel met with a representative of the Swiss Federal Nuclear Safety Inspectorate (ENSI). The purpose of the meeting was to discuss NRC's Freedom of Information Act (FOIA) program and other ways by which NRC makes information available to the public. NRC staff explained the openness and transparency policies of the Obama Administration and NRC's robust proactive program for releasing information to the public. The NRC's Public Document Room and the publicly available Agencywide Documents Access and Management System were also discussed. The ENSI representative provided an overview of the Swiss equivalent of the FOIA.

Controlled Unclassified Information

On March 13, 2012, staff from the Information and Records Services Division attended a working group meeting at the Controlled Unclassified Information (CUI) Office, National Archives and Records Administration. The purpose of the meeting was to begin development of the safeguarding policy for CUI. There will be at least two more working group meetings to discuss and develop safeguards policy.

NRC Staff Present at the Nuclear Waste Technical Review Board (NWTRB) Meeting

On March 7, 2012, U.S. Nuclear Regulatory Commission (NRC) staff participated in the NWTRB meeting in Albuquerque, New Mexico to Focus on Geologic Disposal of Nuclear Waste. Presentations at the meeting focused on the geologic disposal of high-level waste including deep-borehole disposal. NRC staff made a presentation with respect to lessons learned during the preparation of the Technical Evaluation Reports for Yucca Mountain.

Meeting with the Environmental Protection Agency (EPA) to Discuss How the Blue Ribbon Commission (BRC) Report May Affect Geological Disposal

On March 13, 2012, NRC staff met with visiting EPA staff representatives to discuss how the BRC on America's Nuclear Future final report might affect each agency's work on geologic disposal. Discussions focused on (1) potential implications on coordination and collaboration between EPA and NRC, (2) potential processes to develop standards and regulations, and (3) EPA concerns on how a revised standard (40 CFR 191) for disposal could impact the Waste Isolation Pilot Plant. EPA is beginning to inform senior management on the BRC report. EPA noted movement forward would be controlled by budgetary constraints and the release of the Department of Energy's response to the BRC report (due in July).

Meeting with EPA to Discuss Upcoming Advanced Notice of Proposed Rulemaking (ANPR) for 40 CFR 190

On March 13, 2012, NRC staff met with visiting EPA staff representatives seeking NRC staff's informal input on potential revisions to 40 CFR Part 190. Discussions concerned the potential content of a forthcoming ANPR that EPA will soon submit to the Office of Management and Budget. National Fire Protection Association 805 Audit of Fort Calhoun Nuclear Station

During the week of March 5, 2012, NRC staff and contractors performed a regulatory audit of the Fort Calhoun Nuclear Station's application to transition their fire protection program to Nation Fire Protection Association (NFPA) 805. The NRC audit team reviewed NFPA 805 transition documents, conducted interviews; participated in breakout meetings with licensee staff and contractors, and toured the plant to further their understanding of Fort Calhoun's Fire Protection Program. The audit report will be published in the upcoming weeks.

Public Meetings Related to the License Renewal Process for Callaway Plant, Unit 1

On March 14, 2012, the staff conducted two public meetings in Fulton, MO, to discuss the license renewal review process and to solicit public comments concerning the scope of the environmental review for the Callaway Plant, Unit 1, license renewal application. Approximately 50 people attended the meetings, including the applicant, local residents, government officials, citizen organizations, and news media. Public comments included concerns regarding the safety of nuclear power, desire for a longer period of time to submit comments, and support for license renewal. Public comments on the scope of the environmental review are due by April 24, 2012.

Office of Nuclear Regulatory Research Publication of Regulatory Guide 7.4, "Leakage Tests on Packages for Shipment of Radioactive Materials"

On March 9, 2012 the staff published Revision 1 of Regulatory Guide 7.4, "Leakage Tests on Packages for Shipment of Radioactive Materials." The regulatory guide was revised to endorse and incorporate revisions to American National Standards Institute (ANSI) Standard N14.5, "Radioactive Materials - Leakage Tests on Packages for Shipment" as well as to address revisions to 10 CFR 71.51, "Additional Requirements for Type B Packages" that were implemented since the guide was originally issued in June 1975.
