Subject: Petition for Rulemaking to Revise **10 CFR 50**: Radionuclide Monitoring; **10 CFR 20**, Regulatory Guides **1.21 (2008)** and **4.1 (2008)** and other applicable Regulatory Guides as

documented within the petition.

Purpose: To update requirements for upgraded and new technology in Radionuclide Monitoring instrumentation in nuclear power plants.

This Rule Change is necessary with the advent of advanced instrumentation as identified in various Regulatory Guides starting in 2008, the Near-Term Task Force Review report on the Fukushima Dai-Ichi accident (2011), and the continuing Tritium and other radionuclide leaks at various nuclear power plants. Clarification between documents regarding ‘principal radionuclides’ is also needed.

In light of the text revisions needed in some of the reviewed Regulatory Guides we respectfully submit revised text in the form of the attached Word Documents with track changes for your consideration. These text revisions have been applied to Regulatory Guides: 4.16, 4.21, 8.25, and NUREG-1400. A chart documenting the locations of the various text edits is provided at the end of References for your convenience.
