SUBJECT: NOTICE OF CANCELLATION OF USEC INC'S. CLASSIFIED CYBER SECURITY
PLAN SP-3605-0001

Dear Mr. Miner:

I am responding to your March 22, 2012 (AET 12-0024), letter notifying the U.S. Nuclear Regulatory Commission (NRC) of the cancellation of Classified Cyber security Plan SP-3605-0001, Stand Alone Information System Security Plan (ISSP) Processing Classified Information at Protection Index PI-2 (Revision 0), which will be effective on March 23, 2012. In your letter you stated that, based on discussions during the January 17-20, 2012, onsite readiness review of the American Centrifuge Operating, LLC, Security Program under the NRC/U.S. Department of Energy (DOE) common set of requirements, it was agreed to by the NRC, the DOE, and USEC Inc. (USEC) that this plan was no longer needed. In your letter, you also stated that USEC will now use the form provided by the NRC entitled NRC Quick Computer Check List for Standalone Classified Systems, which is captured within USEC's operating procedure for Classified Information Systems Security Administration.

The NRC has completed the review of your submittal and, as a result, has approved your request. The NRC is officially cancelling the accreditation of SP-3605-001. Therefore, the NRC has proceeded to amend condition 10(j) of materials license SNM-7003 for the American Centrifuge Lead Cascade Facility by deleting references to this plan. The revised license will be provided under separate correspondence. Revision of Enclosure 5 of USEC's letter AET 11-021, dated April 21, 2011, which provided Revision 1 of SP-3605-0001 for NRC's review and approval, is now discontinued.

We would also like to take this opportunity to inform you that, due to issues with the new NRC accounting and new time and labor reporting systems, Technical Assignment Control (TAC) L33133 (Request to Review Security Program for American Centrifuge Operating) has been officially closed. Work under this TAC will now continue under new TAC L34141. Please reference this TAC number for future correspondence regarding this matter.

In accordance with Title 10 of the *Code of Federal Regulations* 2.390(d) of the NRC "Rules of Practice," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records System component of NRC's Agencywide Documents Access and Management Systems (ADAMS).
