This letter forwards Submissions 10 (non-public version) and 11 (public version) of the North Anna 3 Combined License Application (COLA). The submissions include revisions to Part 1, *General and Administrative Information*, Part 2, *Final Safety Analysis Report*; and Part 3, *Environmental Report*.

The revisions to the COLA reflect updated information related to the transfer of Old Dominion Electric Cooperative (ODEC) interests in North Anna Unit 3 to Dominion Virginia Power (Dominion). The revisions also reflect responses to NRC requests for additional information (RAIs) through January 31, 2012.

Enclosure 1 consists of one DVD containing Submission 10, which is conspicuously marked with "Withhold from Public Disclosure under 10 CFR 2.390" because proprietary information is contained in Parts 1 and 3, and security-related sensitive information (SRI) is contained in Parts 2 and 3. Information of these types is collectively designated Sensitive Unclassified Non-Safeguards Information (SUNSI). The proprietary information in Parts 1 and 3 should be withheld from public disclosure in accordance with 10 CFR 2.390(a)(4). An affidavit providing the justification for treating the information as proprietary is provided in Enclosure 3. In accordance with NRC Regulatory Issue Summary 2005-26, an affidavit to support withholding of SRI is not required.

A second DVD containing Submission 11 is provided as Enclosure 2. This DVD contains a public version of the submission.

	AFFIDAVIT OF FLIGENE'S GRECHECK

- I, Eugene S. Grecheck, Vice President Nuclear Development of Virginia Electric and Power Company, dba Dominion Virginia Power (Dominion), being duly sworn according to law, depose and state the following:
- 1. I am authorized to execute this affidavit on behalf of Dominion.
- 2. Dominion is submitting to the NRC a revision to the North Anna Unit 3 Combined License Application, designated as Dominion letter No. NA3-12-005. Enclosure 1 of Dominion letter No. NA3-12-005 (designated as Submission 10) contains certain proprietary financial information that should be held in confidence by the NRC pursuant to 10 CFR 9.17(a)(4) and 2.390(a)(4). The proprietary financial information is identified in the enclosure by bracketed text and marginal annotations. This information should be withheld from public disclosure because:
 - a. The information is and has been held in confidence by Dominion.
 - b. This information is of a type that is held in confidence by Dominion, and there is a rational basis for doing so because the information contains sensitive financial information concerning Dominion's estimated construction costs related to North Anna Unit 3.
 - c. This information is being transmitted to the NRC in confidence.
 - d. This information is not available in public sources and could not be gathered readily from other publicly available information.
 - e. Public disclosure of this information would create substantial harm to the competitive position of Dominion by disclosing confidential Dominion financial information associated with construction costs for North Anna Unit 3 to other parties whose commercial interests may be adverse to those of Dominion. The use of this confidential financial information by competitors would permit them to use the information developed by Dominion without the expenditure of similar resources, thus giving them a competitive advantage.
- 3. Accordingly, Dominion requests that the designated document be withheld from public disclosure pursuant to the policy reflected in 10 CFR 2.390(a)(4) and 9.17(a)(4).
