"NEI 99-01 DRAFT REVISION 6 DISCUSSION"

The purpose of this public meeting with the Nuclear Energy Institute (NEI) and industry representatives, known as the Emergency Action Level (EAL) Task Force, was to discuss NEI's proposed revision to NEI 99-01, "Methodology for Development of Emergency Action Levels," (ADAMS Accession No. ML110240324).

The Nuclear Regulatory Commission (NRC) stressed the importance of understanding that issues raised and discussed were to be considered pre-decisional and only to be considered the opinion and viewpoints of the technical staff rather than an official NRC position. In addition, the staff stressed the importance of understanding that positions may change throughout the endorsement process.

The EAL Task Force and the NRC staff discussed the draft revision 6 of NEI 99-01 from the hazards section material and definitions section.

A discussion related to the importance of providing significant justification for the removal of EALs, or the significant revision of existing EALs, occurred such that the staff's expectation for justification quality was presented.

The staff reiterated that the scope of this revision to NEI 99-01 does not include a redefinition of the terms Unusual Event, Alert, Site Area Emergency, or General Emergency as these are historically well-defined terms and do not require revision.
