Pursuant to Reference 1, STP Nuclear Operating Company (STPNOC) is notifying the NRC that STP intends to install the final two high density spent fuel storage racks 12 and 16 (2 per Unit) no later than December 31, 2013.

STP filed an amendment to the operating license in 1988 (Reference 2) to install high density racks in the spent fuel pool. This request was approved by the NRC in 1988 (Reference 3). Subsequently, STP notified the NRC that it would not install two racks (Reference 1). In this letter, STP committed that

"Future installation of these 2 racks will be in accordance with the guidelines of NUREG-0612 "Control of Heavy Loads at Nuclear Power Plants". Additionally, steps will be followed to ensure spent fuel will not be stored in the fuel storage cells adjacent to the uninstalled racks to minimize radioactive sources next to the spent fuel pool's southeast corner where fuel handling operations may be performed and where future rack installation will occur. HL&P will notify the NRC prior to final rack installation to describe the steps taken to achieve worker radiation exposures ALARA and to ensure NUREG-0612 guidelines are followed."

A OOI NRR STP now plans to install the final two storage racks. The seismic analysis design basis of the racks is bounded by the results described in Reference 2. The configuration for criticality analysis in Region 2 racks is based on considerations for fuel in adjacent cells. The addition of the 2 racks in the spent fuel pool will not alter the analysis configuration.

The detailed steps taken to achieve worker radiation exposure ALARA are encompassed in the associated site procedures. A formal plan will be developed by installation personnel and Radiation Protection (RP) to support maintaining dose ALARA. This plan will be submitted to the ALARA Review Committee for approval prior to a challenge review. Special consideration will be given to the control of contamination when rigging or other components are being removed from the SFP.

Additionally, the installation of the remaining racks will be performed in accordance with site procedure," Control of Heavy Loads" ensuring NUREG-0612 guidelines are followed.

There are no regulatory commitments in this letter.
