

When and if the amount(s) paid and payable to the contractor hereunder shall equal the obligated amount, contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the contractor in excess of the obligated amount specified above is done so at the contractor's risk.
