The license is amended to: 1) increase the maximum total quantity authorized for export from 740 TBq/year (20,000 Ci/year) to 2220 TBq/year (60,000 Ci/year); and 2) extend the expiration date from January 31, 2015 to January 31, 2017.

All other conditions remain the same.
