Public Web Site Content Delivery and Continuity of Operation Services

On March 23, 2012, as a result of a non-competitive solicitation, a firm-fixed-price General Services Administration Federal Supply Schedule task order (GS-35F-0626M/NRC-HQ-12-F-33-0001) was awarded to Akamai Technologies, Inc. of Reston, VA. This task order will provide the NRC with maintenance and assistance to distribute and deliver hypertext transfer protocol content and provide Continuity of Operations services for the NRC public Web site. The base period of performance is February 1, 2012, to January 31, 2013, with a 6-month option period from February 1, 2013, to July 31, 2013. The total value of the contract is \$482,038, inclusive of the option.

Human Resource Education Grants

On March 30, 2012, 52 grants were awarded to Higher Educational Institutions across the United States and Puerto Rico. The grants range in value from \$25,000 to \$450,000, for a total value of \$13,949,204. These grants will provide support for fellowships, scholarships, faculty development, and curriculum development programs at the various education entities. The period of performance will start April 1, 2012, and depending on the grantee and the program, could be modified and extended up to 5 years from the date of award.

Meeting with Spring Insulated Conductor Committee

From March 26 to March 28, 2012, staff participated in the Spring Insulated Conductor Committee meeting in Seattle, WA. During the meeting, the staff participated in several working groups and discussion groups related to the design and testing of power cables. The staff also participated in a question and answer forum related to power cable issues affecting the nuclear industry. One specific item of interest was submergence of medium voltage power cables. At the conclusion of the question and answer forum, the meeting participants decided to begin formulating a technical white paper to address the impact that submergence has on medium voltage modern ethylene propylene rubber (EPR) cables with the intent to show that these cables are not as susceptible to water damage as other medium voltage cable types.

International Atomic Energy Agency (IAEA) Meeting in Vienna

From March 26 to March 30, 2012, staff attended and co-chaired the IAEA Working Group 2 and 3 meetings in Vienna, Austria. The purpose of the meetings was to support the development of IAEA International Generic Aging Lessons Learned document for life extensions of nuclear power plants by the member states. NRC participants provided input on acceptable aging management programs and aging management review line items related to electrical, instrumentation control, and structural components and systems. Members from 16 countries participated in the meeting.

Public Meeting with Boiling Water Reactor Owner's Group

On March 28, 2012, staff participated in a public meeting with the Boiling Water Reactor Owner's Group (BWROG). The purpose of the meeting was to discuss the ongoing issues regarding the BWR emergency core cooling system suction strainer resolution effort. The meeting included a schedule update from the BWROG Chairman. The BWROG Chairman stated that the effort will require an additional two years to complete due to complications with establishing contracts with Westinghouse and Areva for downstream effects fuel assembly testing. Some intermediate milestones have been delayed, and the final milestone date will be extended to year 2017. The BWROG will provide an updated schedule of all milestones in mid-May.

Revision 4 of Regulatory Guide 1.82, "Water Sources for Long-Term Recirculation Cooling Following a Loss-of-Coolant Accident"

On April 2, 2012 the *Federal Register* Notice (77 FR 19740) was published announcing the release of Revision 4 of Regulatory Guide (RG) 1.82, "Water Sources for Long-Term Recirculation Cooling Following a Loss-of-Coolant Accident." This regulatory guide describes methods that the NRC staff considers acceptable to implement requirements regarding the sumps and suppression pools that provide water sources for emergency core cooling, containment heat removal, or containment atmosphere cleanup systems. Revision 4 of RG 1.82 provides guidelines for evaluating the adequacy and the availability of the sump or suppression pool for long-term recirculation cooling following a loss-of-coolant accident.
