Jan and Alan,

I have reviewed the clean pages in the PRNMS SE and have found no more errors. However, I do have a question -
TS Table 3.3.1.1-1, which is now on pages 3.3-6, 3.3-6a (new), 3.3-7, and 3.3-8, has a heading as follows:

Table 3.3.1.1-1 (page <#> of 3)
Reactor Protection System Instrumentation

Since 3.3-6a is a new page, should the heading change to indicate "page <#> of 4"? If so, this means the heading for other pages of the table need to change, as well. (They were not impacted by the PRNMS LAR.) Also, page 3.3-6a doesn't have a heading, Should it?

When developing the clean TS pages for the EPU LAR, Dana was able to get the notes on the same page with the table. This does away with the new 3.3-6a page. Would you want to take that approach?
