On March 7, 2012, Latischa Hanson of Region IV conducted a safety and security inspection at the TMDE Support Center, Logistics Lane, Building 88039, Fort Hood, Texas of activities authorized by the above listed NRC license. The inspection was an examination of your licensed activities as they relate to radiation safety and to compliance with the Commission's regulations and the license conditions. The inspection consisted of observations by the inspector, interviews with personnel, and a selective examination of representative records. Additional information provided in the telephone conversations held March 8 through 16, 2012 between Natasha Tabor of your organization and Latischa Hanson of Region IV was also examined as part of the inspection. The findings of the inspection were discussed with Natasha Tabor of your organization at the conclusion of the inspection.

Within the scope of this inspection, no violations were identified.
