Ladies and Gentlemen:

Eastern Connecticut Cardiology Diagnostics, LLC (the "**Transferor**") and Lawrence & Memorial Hospital, Inc. (the "**Transferee**") hereby request consent to transfer of the License from the Transferor to the Transferee. The facility is located at 196 Parkway South, Suite 103, Waterford, Connecticut 06385.

There are no changes in personnel or duties, except for the following: Certain members of the existing staff of the Transferor will be hired by the Transferee at the time of the asset transfer and will provide services at the facility after the transfer. In addition, certain members of the Transferee's existing staff may provide services at the facility after the transfer of assets. A list of the staff members who may provide services after the transfer and their training and experience is attached as Exhibit A.

3. Describe any changes in the organization, location, facilities, equipment, or procedures that relate to the licensed program.

No changes are expected in the organization, location, facilities, equipment or procedures relating to the licensed program after the transfer.


