- 2. Number of students enrolled in new STEM courses;
- 3. Number of these enrolled students retained in STEM major."
- Revise the reporting requirement period for the Federal Financial Report (FFR, SF-425) to a semiannual basis. Under Attachment C – Standard Terms and Conditions; Monitoring and Reporting §215.51, "b. Federal Financial Reports" deleted in its entirety and replaced with the following:
  - "b. Federal Financial Reports

The Grantee shall submit a "Federal Financial Report" (SF-425) on a semi-annual basis for the periods ending March 31 and September 30, or any portion thereof, unless otherwise specified in a special award condition. Reports are due no later than 30 days following the end of each reporting period. A final SF-425 is due within 90 days after expiration of the award.
