**SUBJECT: TERMINATION OF NRC RADIOACTIVE MATERIALS LICENSE**

By letter dated February 28, 2012, you informed the U.S. Nuclear Regulatory Commission (NRC) that Acura Engineering Colorado, LLC wished to terminate NRC radioactive materials license number 05-29368-01. The NRC Form 314 dated January 27, 2012, stated that all radioactive material had been transferred to the State of Colorado radioactive materials license number 375-02 issued to Acura Engineering Colorado, LLC.

The NRC staff has reviewed the supporting documentation to your NRC Form 314. The leak test results document that there was no leakage of radioactive material from the sealed sources. Based on this information and a review of your historical file, the staff concluded that all licensable radioactive material has been removed from your facility located at Rainbow Hydroelectric Plant, 6720 Rainbow Dam Road, Great Falls, Montana. This facility is suitable for unrestricted use in accordance with 10 CFR 20.1402, "Radiological Criteria for Unrestricted Use." No further remediation or actions with respect to NRC regulated material is required.

Enclosed is Amendment No. 01 to NRC License No. 05-29368-01 authorizing your license termination. An environmental assessment for this action is not required since this action is categorically excluded under 10 CFR 51.22(c)(20)(ii).
