INFORMATION FROM PUBLIC DISCLOSURE FOR AREVA FUEL  
TRANSITION DOCUMENTS (TAC NO. ME3775)(TS-473)

Dear Mr. Shea:

By letter dated October 7, 2011, you submitted an affidavit dated September 30, 2011, executed by Alan B. Meginnis of AREVA NP, Inc. It was requested that the information contained in the following documents be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

- ANP-3035(P), *AREVA Responses to August 2011 RAIS for Browns Ferry Unit 1 Fuel Transition-LOCA*, Revision 0; and
- ANP-3015(P), *Browns Ferry Units 1, 2, and 3LOCA Break Spectrum Analysis*, Revision 0.

A nonproprietary copy of these documents has been placed in the U.S. Nuclear Regulatory Commission's (NRC's) Public Document Room and added to the Agencywide Documents Access and Management System Public Electronic Reading Room.

The affidavits stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- The information reveals certain distinguishing aspects of a process, methodology, or component, the exclusive use of which provides a competitive advantage for AREVA NP in product optimization or marketability; and,
- The information is vital to a competitive advantage held by AREVA NP, would be helpful to competitors to AREVA NP, and would likely cause substantial harm to the competitive position of AREVA NP.

The NRC staff has reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.
