Mr. Gattone:

In response to your inquiry this morning regarding PSI's 03/14/2012 submittal pursuant to NRC Confirmatory order EA-10-161 (specifically, the attached Addendum 1, Section 3, item 3.2.7), the text was taken directly from the Confirmatory Order, Section III, item 8 which reads:

"Serious deficiencies (such as untrained personnel, not wearing dosimetry, unsafe operations or security issues) identified during the audit will be discussed with local and corporate radiation safety officers within 24 hours of the observation and a plan to correct the problem will be put into place within the following 48 hours following the conversation."

PSI's response exceeded the requirements of the Confirmatory Order text (above), but to further clarify PSI would immediately suspend industrial radiographic operations that represented a significant violation of PSI procedures or the applicable regulations (or otherwise presented a threat to the health and safety of personnel or the general public), including untrained or unauthorized individuals working as a Radiographer or Radiographer's Assistant.
