This refers to your license amendment request dated January 2, 2012. Enclosed with this letter is the amended license removing José O. Morales, M.D. as an authorized user. Because you indicated you would not be able to supply the additional information required to add Dr. Carlos Montalván Miró as an authorized user for some time, we have not added him to the license. Once you obtain the additional information, you may resubmit your request. Dr. Carlos Montalván Miró may practice under the supervision of Dra. Lourdes García or Dr. Carlos García until you provide the information requested in our letter dated March 12, 2012, and our review of such information results in the requested amendment.

Please note that we have revised the maximum possession limit for 10 CFR 35.300 to 1.5 curies.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
