I am responding to your April 9, 2012, email regarding the follow-up to your Oyster Creek fire protection concerns.

In none of your three concerns was OB-FZ-6B specifically referenced. It has been the NRC staff's position that Thermo-Lag 330-1 is combustible. Based on the NRC staff evaluation, the manual actions requested in the exemption request are considered acceptable, in accordance with 10 CFR 50.12, even in the presence of the Thermo-Lag in OB-FZ-6B.

The staff has no plans for remediation action.

Greetings,

Per your request I am replying in receipt of NRC's finding and the dismissal of my fire protection allegation for Exelon's Oyster Creek nuclear power plant.

The agency's response at present fails to address or specifically reference fire zone OB-FZ-6B and the combustible loading from the presence of unprotected Thermo-Lag 330-1 in Oyster Creek which is central to my allegation.

Please provide me with a written response from the agency with regard to its finding specific to OB-FZ-6B as addressed in the 1998 Thermo-Lag 330-1 Order as a high priority for specified remediation actions, represented to NRC by Exelon in its 2001 closeout of the Order as completing the specified remediation actions and then subsequently identified as contributing to approximately 29% of the combustible loading for this same fire zone in 2010 RAI for the 2009 exemption request.

I plan to contact Ms. James by telephone with this same request.
