Via Reference (1), NextEra Energy Point Beach, LLC (NextEra) submitted a proposed emergency license amendment request for Commission review and approval pursuant to 10 CFR 50.90 and 10 CFR 50.91(a)(5) to Renewed Facility Operating Licenses DPR-24 and DPR-27 for the Point Beach Nuclear Plant (PBNP) Units 1 and 2, respectively. Via Reference (2), NextEra supplemented the Reference (1) license amendment request. The Reference (2) supplement superseded the Reference (1) submittal in its entirety.

NextEra has concluded that the proposed changes requested in Reference (2) are no longer necessary, since standby emergency power has been restored to the 1A05 and 2A05 buses. Accordingly, the provisions of 10 CFR 50.91(a)(5) no longer apply. Therefore, NextEra hereby withdraws License Amendment Request 268, Supplement 1, "One-Time Only License Amendment to Add Notes for Technical Specifications 3.8.1 and 3.8.2 Actions to Address Nonconformance with Point Beach Nuclear Plant GDC 2."

This letter contains no new Regulatory Commitments and no revisions to existing Regulatory Commitments.
