Please be advised that United States Testing Company, Inc. has elected to make an organizational change relative to radiation safety and to change the mailing address.


The attached internal announcement (Attachment A) which reflects the planned radiation safety organization to be in effect August 1, 1992 and thereafter. The position "Corporate Radiation Safety Officer" will report to the Senior Vice President, SGS Industrial Services. This reporting line makes the Senior Vice President responsible for the radiation safety of all of United States Testing Co., Inc. operations. The newly created position "Radiation Safety Program Monitor/Advisor" will serve in a consultative role and will have direct access to the President and CEO through the Director, Corporate Quality Assurance. This organization simultaneously preserves the separate reporting lines while assuring that radiation safety responsibility rests with the operating supervision, thus thus effectively relieving the Site RSO's of the operational restraints of cost and scheduling. The third party annual audit program will of course be retained.

Mr. Randy Sweet has been appointed to fill the position of Corporate Radiation Safety Officer and Mr. William Cain will serve as the Assistant Corporate Radiation Safety Officer. Both have extensive and successful experience as Radiation Safety Officers for radiographic and nuclear gauge operations. Their resume's of experience and qualifications are submitted herein (Attachment B). I shall assist in all aspects of this phase over of responsibilities and will serve in an ongoing function as Radiation Safety Program/Monitor/Advisor.
