SUBJECT: REQUEST FOR ADDITIONAL INFORMATION

The U.S. Nuclear Regulatory Commission (NRC) has initiated the technical review of Burgess Engineering & Testing, Inc. renewal application received on February 21, 2012, and additional information is needed to continue the review process. Please provide the following information within 30 days of receipt of this letter. Make reference to mail control number 576993 when providing your response.

1. Item 3 of NRC Form 313 needs to be corrected to replace the Oklahoma address with the term "temporary job sites in NRC jurisdiction". In addition, Item 13 was left blank. Resubmit a corrected signed and dated NRC Form 313. This form can be found at: <http://www.nrc.gov/reading-rm/doc-collections/forms/>.
2. Complete Appendix B of NUREG-1556, Volume 1, revision 1, and submit. NUREG-1556, Volume 1, Revision 1, provides guidance on the type of information that needs to be submitted to the NRC in support of a renewal application. This document is found at: <http://www.nrc.gov/reading-rm/doc-collections/nuregs/staff/sr1556/v1/r1/sr1556v1r1.pdf>.
3. The commitment listed in Item 10, "Radiation Safety Program – Operating and Emergency Procedures" found in Appendix B is outdated. Do not check any of the boxes in Item 10, "Radiation Safety Program – Operating and Emergency Procedures." Commit to the following updated language in your response letter.

"We will implement and maintain the "Operating, Emergency, and Security Procedures" as described in the errata sheet to Appendix H of NUREG-1556, Volume 1, Revision 1, and provide copies of these procedures to all gauge users and at each job site."
