#### Street Number Unavailable, FM 445: Barn 3 (Property #416)

Constructed circa 1945, Barn 3 (Figures 274 and 275) consists of three components: two parallel, front gabled barns attached to a shed-roofed addition facing FM 445. Both the front-gabled barns and the shed-roofed addition are constructed on vertical wood siding, and each has a metal roof. The barn retains its integrity and reflects the agricultural activities on which the town and the ranch were founded, and is therefore recommended as contributing to the proposed Town of McFaddin Historic District. The building is located approximately 5.8 km (3.6 mi) from the center point of the project site. As discussed in the section titled "Potential for Visual Impacts on the Proposed Town of McFaddin Historic District and its Contributing Resources," the proposed structures (at either 166 or 250 feet in height) and associated steam plume would have an adverse effect on the proposed district, and on Barn 3 as a contributing resource.

# Street Number Unavailable, FM 445: Barn 4 (Property #511)

Constructed circa 1920, Barn 4 (Figure 276) consists of a front-gabled corrugated metal barn attached to a shed-roof one-story side projection, also constructed of corrugated metal. Both components have corrugated metal roofs. The building currently houses the fire truck for the McFaddin Volunteer Fire Department. The barn retains its integrity and is recommended as contributing to the proposed Town of McFaddin Historic District. The building is located approximately 5.9 km (3.7 mi) from the center point of the project site. As discussed in the section titled "Potential for Visual Impacts on the Proposed Town of McFaddin Historic District and its Contributing Resources," the proposed structures (at either 166 or 250 feet in height) and associated steam plume would have an adverse effect on the proposed district, and on Barn 4 as a contributing resource.

### Street Number Unavailable, Cushman Road: Barn 5 (Property #512)

Constructed circa 1910, Barn 5 (Figures 277 and 278) is a one-story, front-gabled barn. The barn is constructed of board-and-batten siding and has a corrugated metal roof. A single metal door with horizontal brackets serves as the entry. The barn retains its integrity and reflects the agricultural activities on which the town and the ranch were founded, and is therefore recommended as contributing to the proposed Town of McFaddin Historic District. The building is located approximately 6.7 km (4.2 mi) from the center point of the project site. As discussed in the section titled "Potential for Visual Impacts on the Proposed Town of McFaddin Historic District and its Contributing Resources," the proposed structures (at either 166 or 250 feet in height) and associated steam plume would have an adverse effect on the proposed district, and on Barn 5 as a contributing resource.

# Street Number Unavailable, FM 445: Barn 6 (Property #513)

Constructed circa 1915, Barn 6 (Figure 279) is a one-story, front-gabled barn. The barn has a rectangular footprint and corrugated metal roof and siding. The barn has four large, open entry bays, two on each side elevation. A deteriorating pole barn with wood posts and a metal roof is associated with this barn. The barn retains its integrity and reflects the agricultural activities on which the town and the ranch were founded, and is therefore recommended as contributing to the proposed Town of McFaddin Historic District. The building is located approximately 7.4 km (4.6 mi) from the center point of the project site. As discussed in the section titled "Potential for

Visual Impacts on the Proposed Town of McFaddin Historic District and its Contributing Resources," the proposed structures (at either 166 or 250 feet in height) and associated steam plume would have an adverse effect on the proposed district, and on Barn 6 as a contributing resource.

# Street Number Unavailable, Cushman Road: Barn 7 (Property #514)

Constructed circa 1925, Barn 7 (Figures 280 and 281) is a one-story, front-gabled barn. The barn has vertical wood siding and a corrugated metal roof. The barn has one entry centered on the front elevation. Approximately six large corrugated metal grain storage silos stand adjacent to the barn. The barn retains its integrity and reflects the agricultural activities on which the town and the ranch were founded, and is therefore recommended as contributing to the proposed Town of McFaddin Historic District. The building is located approximately 7.5 km (4.7 mi) from the center point of the project site. As discussed in the section titled "Potential for Visual Impacts on the Proposed Town of McFaddin Historic District and its Contributing Resources," the proposed structures (at either 166 or 250 feet in height) and associated steam plume would have an adverse effect on the proposed district, and on Barn 7 as a contributing resource.

#### Street Number Unavailable, Cushman Road: Barn 8 (Property #515)

Constructed circa 1910, Barn 8 (Figure 282) is a one-story, side-gabled barn. The barn has vertical wood siding and a corrugated metal roof. An inset porch is located beneath the principle roof. One corrugated metal door facing FM 445 is visible. The barn retains its integrity and reflects the agricultural activities on which the town and the ranch were founded, and is therefore recommended as contributing to the proposed Town of McFaddin Historic District. The building is located approximately 8.0 km (4.9 mi) from the center point of the project site. As discussed in the section titled "Potential for Visual Impacts on the Proposed Town of McFaddin Historic District and its Contributing Resources," the proposed structures (at either 166 or 250 feet in height) and associated steam plume would have an adverse effect on the proposed district, and on Barn 8 as a contributing resource.

# Street Number Unavailable, FM 445: Residence 1 (Property #421)

Constructed circa 1920, Residence 1 (Figure 283) is a one-story residence with a side-gabled roof with a sloping rear eave. A shed-roof extension at the front elevation serves as the awning for the front porch, which is inset beneath the extension and is supported by four narrow square posts. The exterior walls are constructed of board-and-batten siding, and the building has a composite shingle roof. Four-over-four double-hung sash windows are located throughout the house. The building has undergone minimal alterations and serves as an excellent example of the regional vernacular style.

Residence 1 is recommended as contributing to the proposed Town of McFaddin Historic District. It is an excellent representative of a domestic single dwelling constructed in the regional vernacular, and reflects building patterns established before prominent national styles influenced regional patterns of construction and design. The building is located approximately 5.6 km (3.5 mi) from the center point of the project site. As discussed in the section titled "Potential for Visual Impacts on the Proposed Town of McFaddin Historic District and its Contributing Resources," the proposed structures (at either 166 or 250 feet in height) and associated steam plume would have an adverse effect on the proposed district, and on Residence 1 as a contributing resource.

#### Street Number Unavailable, FM 445: Residence 2 (Property #516)

Constructed circa 1910, Residence 2 (Figure 284) is a one-story residence constructed of vertical wood siding and a wood shingle roof. Other architectural details are not discernable. At the time of fieldwork, a rear component of the building was deteriorating, but trees obscured a better view of that elevation. The residence reflects the development of the community and is recommended as contributing to the proposed Town of McFaddin Historic District. The building is located approximately 5.6 km (3.5 mi) from the center point of the project site. As discussed in the section titled "Potential for Visual Impacts on the Proposed Town of McFaddin Historic District and its Contributing Resources," the proposed structures and associated steam plume would have an adverse effect on the proposed district, and on Residence 2 as a contributing resource.

### Street Number Unavailable, FM 445: Residence 3 (Property #435)

Constructed circa 1920, Residence 3 (Figure 285) is a one-story residence constructed of board-and-batten siding and a composite shingle roof. A shed roof projecting from the center of the side-gabled roof forms an enclosed entrance vestibule. A dormer in the side gable indicates a one-half or attic story above the first floor. Windows throughout the building are four-over-four double-hung sash. The residence retains its integrity and reflects the development of the community and is therefore recommended as contributing to the proposed Town of McFaddin Historic District. The building is located approximately 5.6 km (3.5 mi) from the center point of the project site. As discussed in the section titled "Potential for Visual Impacts on the Proposed Town of McFaddin Historic District and its Contributing Resources," the proposed structures (at either 166 or 250 feet in height) and associated steam plume would have an adverse effect on the proposed district, and on Residence 3 as a contributing resource.

#### Street Number Unavailable, FM 445: Residence 4 (Property #436)

Constructed circa 1910, Residence 4 (Figure 286) is a one-story residence constructed of board-and-batten siding and a cross-gabled, composite shingle roof. The front-facing gable is one bay wide and features a four-over-four double-hung sash window and a door. The words "Hunter Check Station" are painted in black in the front gable. The building retains its integrity and reflects the development of the community and is therefore recommended as contributing to the proposed Town of McFaddin Historic District. The building is located approximately 5.7 km

(3.5 mi) from the center point of the project site. As discussed in the section titled "Potential for Visual Impacts on the Proposed Town of McFaddin Historic District and its Contributing Resources," the proposed structures (at either 166 or 250 feet in height) and associated steam plume would have an adverse effect on the proposed district, and on Residence 4 as a contributing resource.

#### Street Number Unavailable, FM 445: Residence 5 (Property #437)

Constructed circa 1910, Residence 5 (Figure 287) is a one-story residence constructed of vertical wood plank siding and a composite shingle roof. The residence has a side-gabled roof with low-pitched, sloping eaves. An inset front porch, half the width of the front façade, is located under the sloping eave and has two square wood post supports. Windows are four-over-four double-hung wood sash windows. The residence retains its integrity and reflects the development of the community and is therefore recommended as contributing to the proposed Town of McFaddin Historic District. The building is located approximately 5.7 km (3.5 mi) from the center point of the project site. As discussed in the section titled "Potential for Visual Impacts on the Proposed Town of McFaddin Historic District and its Contributing Resources," the proposed structures (at either 166 or 250 feet in height) and associated steam plume would have an adverse effect on the proposed district, and on Residence 5 as a contributing resource.
