Root Cause Report Evaluation Training

On April 30, 2012, as a result of a small business competitive solicitation, a firm-fixed-price contract (NRC-HQ-12-C-38-0060) was awarded to Management Systems, LLC, of Marlborough, CT. The contractor will provide training to NRC staff in the efficient and effective review of root cause investigations that were conducted by others (e.g., NRC licensees). The period of performance is April 30, 2012, to April 29, 2013, with four 1-year option periods. The total value of the contract is \$608,559, inclusive of all options.

Technical Assistance in Support of the Review of Evacuation Time Estimates

On May 2, 2011, as a result of a noncompetitive acquisition, a cost-plus-fixed-fee type contract (NRC-HQ-12-C-07-0036) was awarded to Southwest Research Institute of San Antonio, TX. The contractor will provide technical assistance in support of the review of evacuation time estimates for licensed nuclear power plants in accordance with new enhancements to emergency preparedness regulations. The period of performance is May 7, 2012, to September 28, 2012, with an optional period through December 30, 2013. The total estimated value of the contract is \$510,899, inclusive of all options.

Petition for Rulemaking; Submitted by the Natural Resources Defense Council, Inc., Proposed Rule; 10 CFR Part 50 (PRM-50-102; NRC-2011-0189)

On April 27, 2012, the NRC published in the *Federal Register* (77 FR 25104) a document to consider the issues raised in the petition for rulemaking (PRM), PRM-50-102, submitted by the Natural Resources Defense Council, Inc. (the petitioner), in the rulemaking process. The petitioner requests that the NRC amend its regulations to require more realistic, hands-on training and exercises on Severe Accident Management Guidelines and Extensive Damage Mitigation Guidelines. The NRC determined that the issues raised in the PRM are appropriate for consideration and will consider them in the ongoing Fukushima Near Term Task Force Recommendation 8 rulemaking (Docket ID NRC-2012-0031). The docket for PRM-50-102 was closed on April 27, 2012.

Emergency Planning Zone, Petition for Rulemaking; 10 CFR Part 50 and 52 (PRM-50-104; NRC-2012-0046)

On April 30, 2012, the NRC published in the *Federal Register* (77 FR 25375) a notice of receipt and request for comment for a petition for rulemaking (PRM), dated February 15, 2012, which was filed with the NRC by Mr. Michael Mariotte on behalf of the Nuclear Information and Resource Service (NIRS or the petitioner) and 37 co-petitioners. The petition was docketed by the NRC on February 17, 2012, and assigned Docket No. PRM-50-104. The petitioner requests that the NRC amend its regulations to expand the emergency planning zones for nuclear power plants. Comments are due by July 16, 2012.

Access Authorization Fees, Direct Final Rule; 10 CFR Parts 11 and 25 (RIN 3150-AJ00; NRC-2011-0161)

On May 3, 2012, the NRC published in the *Federal Register* (77 FR 26149) a direct final rule amending the NRC's access authorization fees charged to licensees for work performed under the Material Access Authorization Program and the Information Access Authority Program. The amended cost is due to an increase in the review time for each application for access authorization. The NRC's formula for calculating fees will remain the same and is based on current Office of Personnel Management investigation billing rates for background investigations. The formula is designed to recover the full cost of processing a request for access authorization from an NRC licensee. The direct final rule is effective June 22, 2012, unless significant adverse comments are received by June 4, 2012. A companion proposed rule was published in the *Federal Register* on May 3, 2012 (77 FR 26213). Comments on the proposed rule are due by June 4, 2012.

Request for Public Comment on Extended Storage and Transportation Technical Information Needs Report

On May 3, 2012, staff released for public comment its draft report entitled "Identification and Prioritization of the Technical Information Needs Affecting Potential Regulation of Extended Storage and Transportation of Spent Nuclear Fuel," as a joint product of the Office of Nuclear Material Safety and Safeguards and the Office of Nuclear Regulatory Research. The report reviews potential degradation mechanisms that could affect dry storage and transportation of spent nuclear fuel, and identifies those where additional technical information may be needed to support future regulatory actions or potential changes in regulations or guidance. The public comment period closes June 18, 2012.

McGuire 1&2 Measurement Uncertainty Recapture Power Uprate Acceptance

By application dated March 5, 2012, the licensee requested a 1.7% measurement uncertainty recapture power uprate for McGuire Units 1 and 2, using Cameron CheckPlus Leading Edge Flow Meter ultrasonic flow measurement instrumentation. By electronic letter dated April 25, 2012, staff informed the licensee that the application was accepted for a detailed technical review.

Public Meeting with Nuclear Energy Institute

On May 3, 2012, the staff held a Category 2 public meeting with Nuclear Energy Institute (NEI) representatives and stakeholders to discuss technical and licensing basis issues related to fire induced circuit failures, including multiple spurious actuations.
