MEMORANDUM AND ORDER  
(Scheduling Initial Prehearing Conference;  
Opportunity for Limited Appearance Statements)

Previously, the Licensing Board indicated that it was likely to conduct an initial prehearing conference to provide the participants with an opportunity to present oral argument regarding any disputes over the standing of petitioner Missouri Coalition for the Environment (MCE) or the admissibility of its three proffered contentions and solicited information from the participants regarding their availability for such a session.
