As required in Title 10, Code of Federal Regulation Parts 30 and 35, we are requesting an amendment to NRC license number 08-01738-02 to:

1. Remove the former Walter Reed Army Medical Center (WRAMC) and associated buildings/use areas at 6900 Georgia Avenue NW, Washington, DC 20307. In accordance with the recommendations of the Defense Base Closure and Realignment Commission pursuant to sections 2903 and 2914 of the Defense Base Closure and Realignment Act of 1990, Public Law 101-510, 104 Stat. 1810, as amended; the former WRAMC was deactivated as a military unit on 15 September 2011. Principal activities under license number 08-01738-02 ceased at the former WRAMC on this date but continue at the Fort Belvoir Community Hospital (FBCH).
2. Radioactive material used at the former WRAMC was decayed-in-storage, moved to the FBCH or transferred to a Department of Defense contracted waste broker for disposal.
3. Reasonable efforts were made to eliminate residual radioactive contamination and a radiation survey was performed which demonstrates that the premises are suitable for release in accordance with the criteria for decommissioning in 10 CFR part 20, subpart E (i.e., utilizing Multiagency Radiation Survey and Site Investigation Manual methods). This survey was performed under contract by TIDEWATER, Inc. for the US Army Corps of Engineers and the licensee on November 7th through December 30th, 2011 and on February 3rd, 2012.
4. The Final Status Survey Report (FSSR) with associated equipment data, methods, survey data, recommendations and references is enclosed. Appendices are provided in electronic format (CD-ROM).
