SUBJECT: WOLF CREEK GENERATING STATION – REQUEST FOR WITHHOLDING
INFORMATION FROM PUBLIC DISCLOSURE (TAC NO. ME8350)

Dear Mr. Sunseri:

By letter dated March 29, 2012 (Agencywide Documents Access and Management System Accession No. ML12102A080), Wolf Creek Nuclear Operating Corporation (WCNOC, the licensee) submitted an affidavit dated February 22, 2012, executed by J. A. Gresham, Manager, Regulatory Compliance, Westinghouse Electric Company LLC (Westinghouse), requesting that information designated proprietary in the following document be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

Westinghouse Electric Company LLC, LTR-SGMMP-11-28 Rev. 1,
P-Attachment, "Response to USNRC Request for Additional Information
Regarding the License Amendment Requests for Permanent Application of the
Alternate Repair Criterion, H*, to the Model D5 and Model F SGs" (Proprietary)

The proprietary version of the document and the Westinghouse affidavit are included as Enclosures I and III, respectively, to the letter dated March 29, 2012.

A non-proprietary version of the document, included as Enclosure II to the March 29, 2012, letter, has been placed in the Nuclear Regulatory Commission's (NRC's) Public Document Room and added to the NRC Library in the Agencywide Documents Access and Management System.

The licensee stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- (a) The information reveals the distinguishing aspects of a process (or component, structure, tool, method, etc.) where prevention of its use by any of Westinghouse's competitors without license from Westinghouse constitutes a competitive economic advantage over other companies.
- (b) Its use by a competitor would reduce his expenditure of resources or improve his competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing a similar product.
- (c) It reveals aspects of past, present, or future Westinghouse or customer funded development plans and programs of potential commercial value to Westinghouse.

We have reviewed your application and material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, have determined that the information sought to be withheld in the two submittals, when the two submittals are considered together, contains proprietary commercial information and should be withheld from public disclosure.


Therefore, the version of the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.
