Steve,

The main purpose of this email is to request another extension on RAI-250 (6342) for 03.03.02. The current agreed upon submittal date is May 24, 2012. Our response is directly linked to MHI's response to an RAI for the US-APWR DCD (908-6327) which was previously scheduled to be submitted on May 2, 2012. The scope of the DCD response is greater than expected and the information will not be submitted for several more weeks. I suggest a one month extension.

**Please extend the due date for RAI-250 (6340) to June 26, 2012.**

A few loose ends:

- We are looking for the NRC to propose a conference call date and time for the hydrology fill properties white paper I provided on April 26.
- I believe that Paul Kallan is going to propose a conference call with Luminant, MHI and the NRC staff on heavy loads. We are waiting for the proposal to confirm that our SMEs are available.
- For the May 24 public meeting, we are estimating about 2 hours for the hydrology discussion and about 4 hours for the seismic discussion. We do not have a preference regarding which subject goes first.
- We are still awaiting a response on the application of GDC 5 to offsite power systems.
- We received the new RAIs sent out last week (through RAI-257, 6457). The UHS related questions are somewhat surprising. These are phase I type questions.
- We are also awaiting some scoping and schedule information for the Chapter 9 audit for this summer.

We can discuss these matters on this Wednesday's conference if you do not have an update sooner.
