

The purpose of this contract modification is to exercise option year three (3) in accordance with FAR Clause 52.217-9, OPTION TO EXTEND THE TERM OF THE CONTRACT, thereby extending the period of performance through June 14, 2013 and increasing obligated amount by \$39,000.00 from \$243,401.83 to \$282,401.83. Accordingly, the contract is hereby modified as follows:

1) Section B.3. DURATION OF CONTRACT PERIOD, is deleted in its entirety and replaced with the following:

"This ordering period for this contract shall commence on June 15, 2009 and will expire on June 14, 2013. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering.) The term of this contract may be extended at the option of the Government for one (1) additional one-year option period.

2) Section B.5 CONSIDERATION AND OBLIGATION--DELIVERY ORDERS (JUN 1988), is deleted in its entirety and replaced with the following:

"The contract obligated funds under this contract are hereby increased by \$39,000.00 from \$243,401.83 to \$282,401.83. The Contracting Officer may issue orders for work up to the amount presently obligated. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.

All other terms and conditions of this contract remain unchanged.
