Enclosed is Amendment No. 53 to your NRC Material License No. 13-12371-01 in accordance with your request. Please note that the major changes made to your license are printed in **bold** font.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

Please note that in Condition No. 12.B. we spelled Dr. Zakel's first name without the "h" at the end, as it appeared in your letter dated February 7, 2012, and attachments. On Dr. Zakel's medical specialty board certification her first name was spelled "Sara" without the "h," which appeared to be more correct. If our understanding is in error and her name is misspelled, please contact me immediately at (630) 829-9841.

At this time we also updated and completed Condition No. 13. by adding section G.

NRC's Regulatory Issue Summary (RIS) 2005-31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS, the NRC's electronic document system.

Pursuant to NRC's RIS 2005-31 and in accordance with 10 Code of Federal Regulations 2.390, the enclosed license document is exempt from public disclosure because its disclosure to unauthorized individuals could present a security vulnerability.

suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions.


