PURPOSE: To discuss and coordinate on-going and planned long-term operability (LTO) research programs being conducted by the Electric Power Research Institute (EPRI), U.S. Department of Energy's Office of Nuclear Energy (DOE:NE) Light Water Reactor Sustainability (LWRS) Program, and the U.S. Nuclear Regulatory Commission's Office of Nuclear Regulatory Research (NRC/RES). These LTO research programs are specifically looking at developing the technical information needed to make regulatory and business decisions regarding possible subsequent license renewal applications for the 60-80 year extended operating period.
