

This is to request a revision to the Sealed Source License, 50-29098-01, for Fairbanks Gold Mining, Inc., Fort Knox, Fairbanks Alaska. The current license states that the Model SA-1 sources require a leak test every 6 months, but according to the Registry, dated January 17, 2003, NO. KY-576-D-I 01-B, pg 6 of 7, Limitations and/or Other Considerations of Use, 3rd bp, a leak test is only required every 36 months for all SA-1 sealed source devices. This resulted in the issuance of a Level IV violation, Notice of Violation on July 28, 2011, Docket 030-34080 against Fairbanks Gold. The violation has been resolved, but it is the desire of Fairbanks Gold to be in compliance with the NRC and the Ronan registry. I am thereby requesting a revision to the license to reflect the 36 month testing interval.

Your attention to this matter would be greatly appreciated.
