The designer has already provided US-APWR physical security hardware ITAAC abstracts MUAP-10003. Dennis,

In Feb. 2011, Dominion received RAIs related to Physical Security Hardware ITAAC (somewhat similar to RAI 211-5494 received by Comanche Peak) and on March 14, 2011 replied that we would wait until this issue was addressed in DCD, Rev. 3 and then address it. However, in July 2011, we answered the RAIs at the request of the NRC to provide the responses prior to the next COLA submission. In COLA S8/9 (December 2011), we provided a change to Part 10, Table C-1 and Chapter 14, Section 14.3.4.12 based on the responses to the RAIs. In the NA3 COLA, Section 14.3.4.12, ITAAC for Physical Security Hardware, the last paragraph reads, “Physical security ITAAC test abstracts supporting the site-specific physical security ITAAC are available for review and inspection prior to implementation.” This sentence was added to point to the ITAAC test abstracts, which will be available for review and inspection, but are not needed at this point in the process.
