

Close-Out for 2059 North Monroe Street, Suite A-2, Monroe, MI

1. Last use of unsealed radioactive material at 2059 North Monroe Street, Suite A-2 was on May 16, 2012.
2. The only unsealed radioisotope in use at this address in the past several months has been Technetium 99m.
3. All calibration and check sealed sources were moved (in accordance with DOT regulations) to our 730 North Macomb Street, Suite 429 address on May 17, 2012. Sealed sources were inventoried and leak tested prior to and after being moved (see results below).
4. Trash left for decay-in-storage was surveyed on May 22, 2012 (6 days after last patient scan) and disposed of at background level.
5. An area radiation survey and wipe testing was performed on May 22, 2012 (see results below). All measurements were background indicating no remaining residual radioactivity at the site.

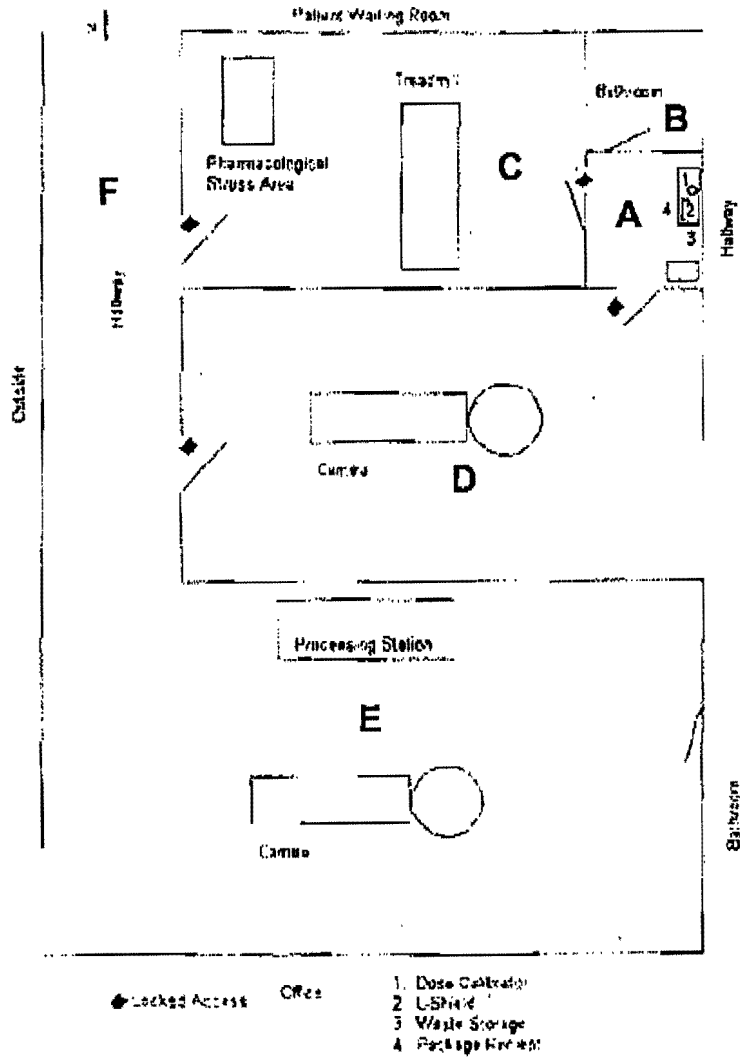
