PURPOSE: This meeting was held at the request Western Nuclear, Inc. (WNI) for the purpose of discussing the remaining activities necessary for license termination.

### BACKGROUND:

WNI completed restoration activities with the approval of alternate concentration limits in September 2006. Since that time, WNI has completed surface decommissioning, and has engaged the U.S. Department of Energy (DOE) to transfer the site to the DOE and terminate the U.S. Nuclear Regulatory Commission (NRC) license.

### DISCUSSION:

WNI stated that it has addressed all regulatory issues and that approval of the long-term surveillance plan (LTSP) is the next step.

DOE stated that it submitted the LTSP to the NRC staff on April 13, 2012. DOE also submitted its proposed long-term surveillance fee to the NRC staff on April 27, 2012. The staff had not seen these documents at the time of the meeting, but would begin the review after receiving them.

DOE stated that some delay might be incurred because the U.S. Army Corps of Engineers was having some funding difficulties. Hopefully these issues will be solved and the title transfer process can proceed.

The meeting attendees agreed to have a status update meeting during the week of July 9, 2012.
