In Reference 1, in accordance with 10 CFR 50.90, "Application for amendment of license, construction permit, or early site permit," Exelon Generation Company, LLC, (EGC), requested an amendment to Appendix A, Technical Specifications (TS), of Renewed Facility Operating License Nos. DPR-19 and DPR-25 for Dresden Nuclear Power Station (DNPS), Units 2 and 3, and Renewed Facility Operating License Nos. DPR-29 and DPR-30 for Quad Cities Nuclear Power Station (QCNPS), Units 1 and 2. The requested change proposed to add an NRC approved topical report reference to the list of analytical methods in TS Section 5.6.5, "Core Operating Limits Report (COLR)," that are used to determine the core operating limits.

In Reference 2, the NRC notified EGC that additional information was needed in order to commence a detailed review of the submittal. Specifically, the NRC requested that EGC provide the completed Emergency Core Cooling System (ECCS) analysis using the proposed new methodology.

The subject ECCS analysis is scheduled to be completed during the Fall of 2012; and therefore, is not available for submittal to the NRC at this time. Subsequently, EGC requests that the license amendment request, transmitted in Reference 1, be withdrawn. A new license amendment request may be submitted at a future date.
