Attached is Final RAI No. 347 (eRAI No. 6502) pertinent to Recommendation 7.1 of the Fukushima Near-Term Task Force recommendations contained in SECY-12-0025. The draft of this RAI was issued on May 11, 2012. A clarification phone call requested by UniStar to discuss the draft RAI was held on May 30, 2012; however, this phone call did not result in any changes to the draft questions. Accordingly, this email forwards the subject RAI as "final" for your response.
