SUBJECT: PERFORMANCE CONTRACTING, INC., APRIL 12, 2012, REQUEST FOR
WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE

Dear Mr. Bleigh:

By letter dated April 12, 2012, you submitted an affidavit dated April 12, 2012, requesting that the information contained in the following documents be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Section 2.390:

- a. PCI Document No. PCI-2012.04.12-1, Rev 1, "Wolf Creek/Callaway Bypass Test Plan," dated December 2011, prepared by Alden Research Laboratory, Inc.
- b. PCI Document No. PCI-2012.04.12-2, Rev 0, "Wolf Creek/Callaway Fiber Bypass Demonstration Test Results," dated February 27, 2012, prepared by Alden Research Laboratory, Inc.

The affidavit states that this information should be considered exempt from mandatory public disclosure because it is:

- a. Information that discloses a process, method, or apparatus, including supporting data and analyses, where prevention of its use by Performance Contracting, Inc.'s competitors without license from Performance Contracting, Inc. constitutes a competitive economic advantage over other companies.
- b. Information which, if used by a competitor, would reduce his expenditure of resources or improve his competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing of a similar product.
- c. Information which reveals aspects of past, present, or future Performance Contracting customer-funded development plans and programs of potential commercial value to Performance Contracting, Inc.

We have reviewed your application and the documents in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the April 12, 2012, affidavit, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure. Therefore, the document listed above will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.
