The purpose of this modification is to provide incremental funding in the amount of \$108,000.00. Therefore, the obligation amount increased by \$108,000.00 from \$134,000.00 to \$242,000.00. In addition, paragraph (c) under clause B.3 "Consideration and Obligation-Cost Plus Fixed Fee (1988) Alt 1" is modified as follows: The amount currently obligated by the Government with respect to this contract is \$242,000.00, of which the sum of \$226,469.73 represents the estimated reimbursable costs, and of which \$15,530.02 represents the fixed fee. Also for FY2012, the G&A rate is changed to 8.69% and the overhead rate is changed to 54.28%.
