CONDITIONS

- 10. This license does not authorize possession or use of licensed material.
- 11. The licensee is authorized to distribute only from its facilities located at 233 Libbey Pkwy., Unit 2, Weymouth, MA.
- 12. The licensee shall submit periodic reports as specified in Section 32.16, 10 CFR Part 32.
- 13. Notwithstanding the labeling requirements of Section 32.15(d), Part 32 as it applies to individual lamps, the licensee shall label each immediate lamp container in accordance with 10 CFR 32.15(d) and as described in the licensee's application dated November 5, 2009.
