14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible)  
The purpose of this modification is to: 1) add additional funding in the amount of \$286,100.00 which increases the obligated amount from \$498,656.25 to \$784,756.25, 2) exercise the option to extend the period of performance from 12/19/11-06/22/12 to 12/19/11-12/31/12, and 3) extend the period of performance an additional 6 months to now end on 06/22/13 at no increase in the contract ceiling.

The purpose of this modification is to;

1) exercise the option in accordance with Federal Acquisition Regulation Clause 52-217-9, in section C.3 of the base contract, entitled, "Option to Extend the Term of the Contract." As a result of this action, the delivery order ceiling amount is increased by \$499,219.38 from \$498,656.25 to \$997,875.63.

2) further extend the period of performance an additional six months at a no-cost increase in accordance with Contract Clause B.3.12 of the base contract, entitled, "Duration of Contract Period," thereby extending the period of performance through June 22, 2013.

3) increase the obligation amount of the task order by \$286,100.00 from \$498,656.25 to \$784,756.25.

The second paragraph of Task Order No. 15 dated December 20, 2011, is deleted in its entirety and replaced with the following:

"Task Order No. 15 obligates funds in the amount of **\$784,756.25**. The obligated amount shall, at no time, exceed the task order ceiling. When, and if, the amount(s) paid and payable to the contractor hereunder shall equal the obligated amount, the contractor is not obligated to continue performance under this task order or otherwise incur costs in excess of the amount obligated until the Contracting Officer notifies the contractor in writing that the obligated amount has been increased. In absence of such notification by the Contracting Officer, the Government is not obligated to reimburse the contractor for any costs in excess of the obligated amount specified herein. Any work undertaken by the contractor in excess of the obligated amount specified herein is done so at the contractor's risk."
