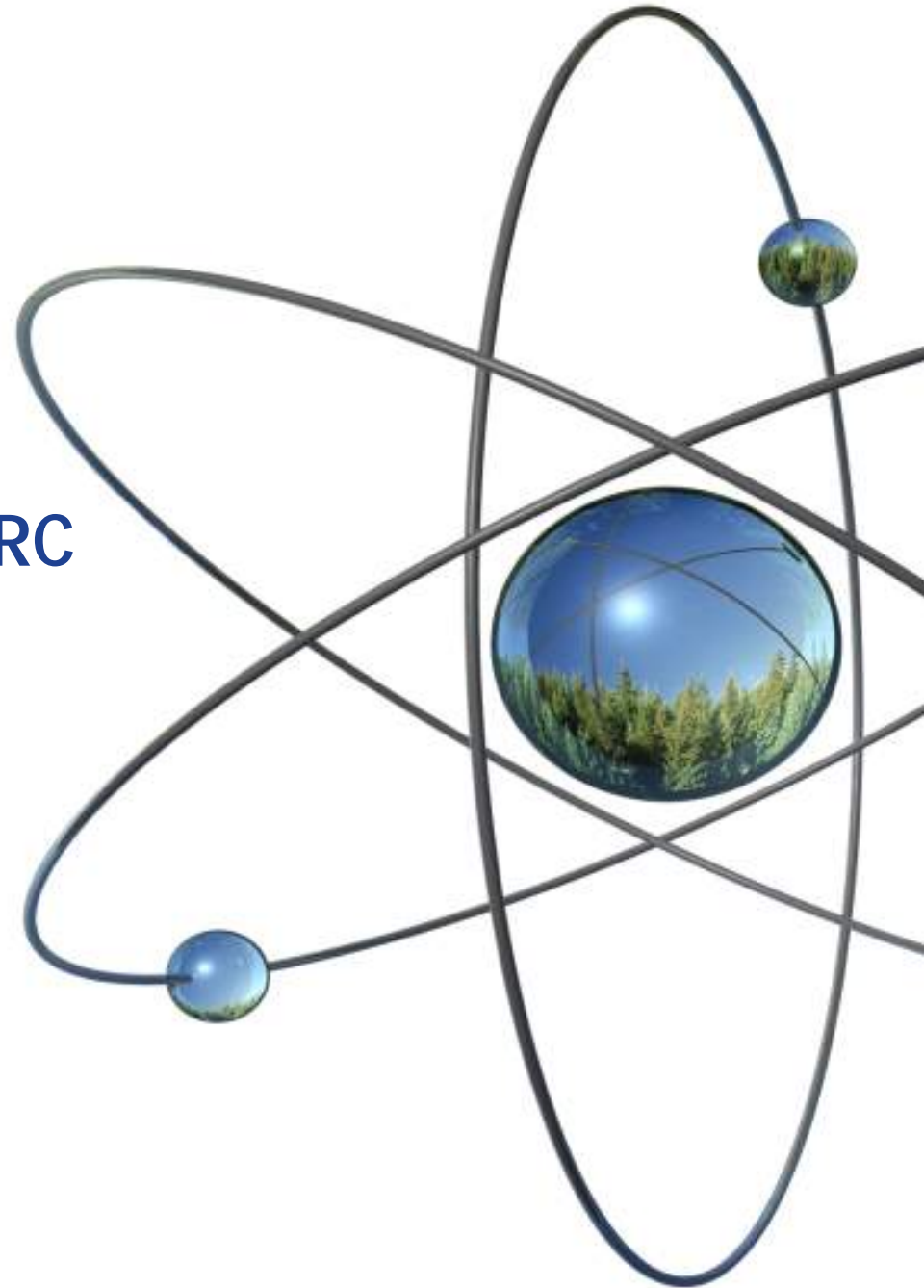

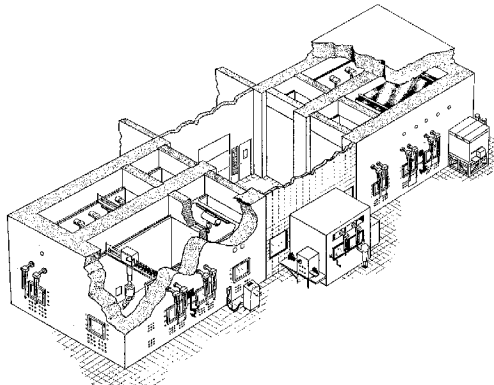

- § Cf-252: nuclear reactor startup and industrial sources

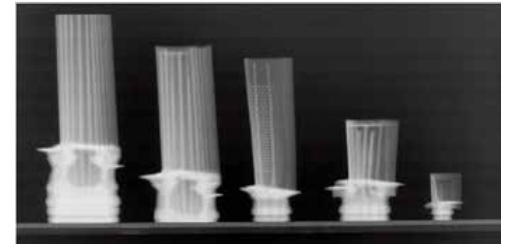


§ Post Irradiation Examination

§ Neutron Radiography

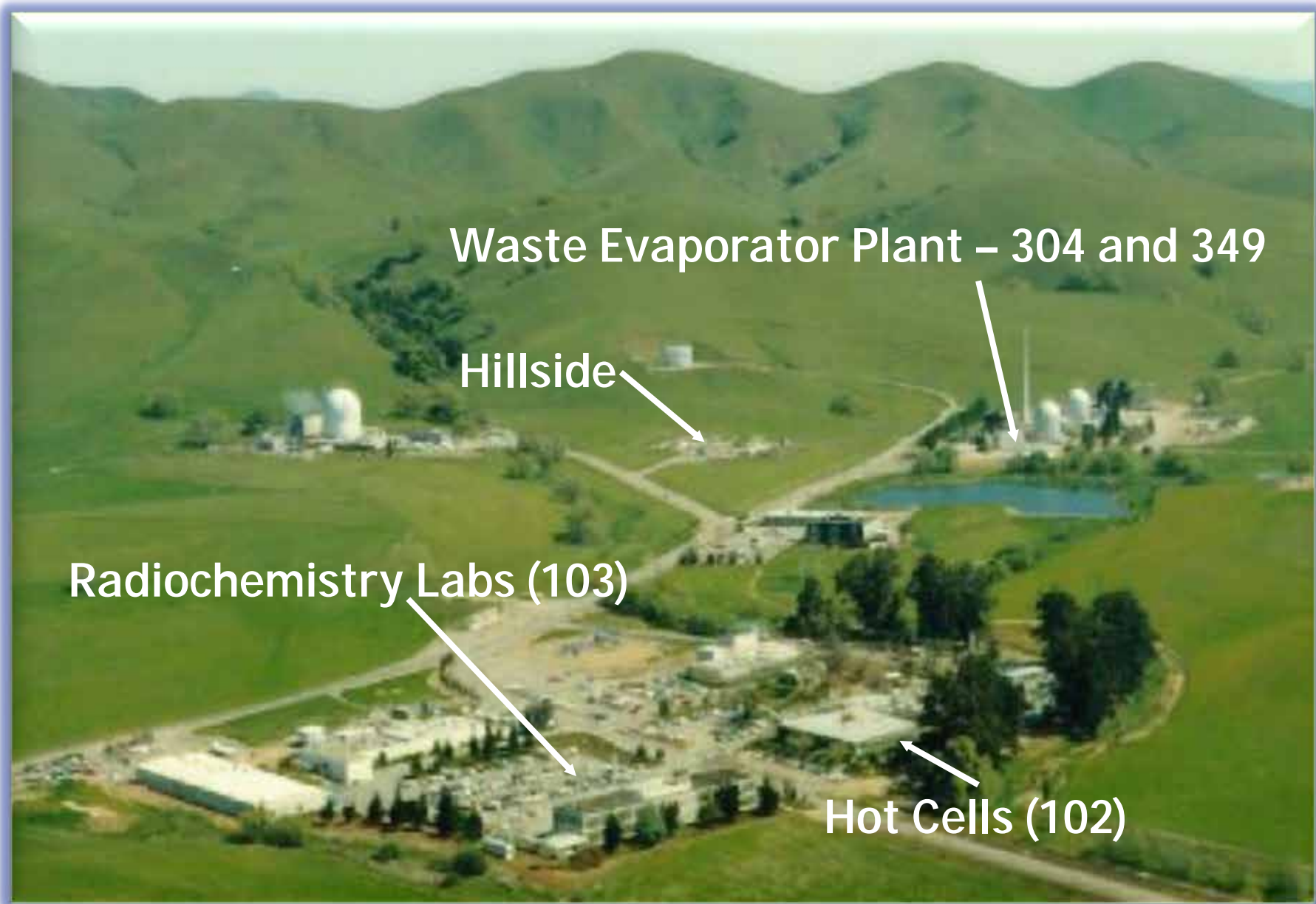
- § Non-destructive examination of hardware & components

Current Status SNM-960

- § LRA initially submitted September 30, 2009
- § License expired June 30, 2010 – timely renewal
- § Revised LRA and DFP submitted April 8, 2011
- § NRC accepted LRA and DFP for review October 31, 2011
- NRC issued first set of RAI's April 3, 2012

- Additional NRC Licenses
 - Possession Only (3) ... Safstor reactors
 - Cask certificates



Proposed process for SNM 960 license

- § Amend CA Agreement State License for SNM use up to 350 g
 - § SNM quantity controlled ... existing accountability system
 - § Activities ... Bldgs 102, 103 & WEP
- § Consolidate SNM to Hillside location from other buildings or remove from site
- § Modify SNM 960 application ... possession and storage of SNM at Hillside exclusively



Licensing Considerations

- § A certification of financial assurance for decommissioning is currently provided to California that covers SNM licensed activities
- § Transfer of SNM licensed activities to California license does not cease principle activities or remove any facility or portion of the site from service
- § NRC Approved Site Physical Security Plan ... No changes anticipated due to proposed SNM process
- § Nuclear Material Control Plan ... procedures are in place and will be maintained under CA license



Plan

- § Submit request to State of California ... amend CA Agreement State License ... SNM use \leq 350 grams
- § Modify, simplify, and consolidate SNM 960 renewal application ... possess and store SNM in Hillside
