Interagency Agreement for PRISM Acquisition System Implementation

On May 31, 2012, an Interagency Agreement (IAA) (NRC-HQ-12-I-10-0008) was awarded to the U.S. Department of Transportation's Enterprise Service Center of Oklahoma City, OK. The IAA will provide for implementation of an NRC Acquisition System, including hosting services and integration to the FAIMIS Core Financial System. The period of performance is from June 1, 2012, to May 31, 2020, with no option periods. The total value of the IAA is \$32,111,402.

Probabilistic Risk Assessment Modeling Support for the Full-Scope Site Level 3 Probability Risk Assessment Project

On May 31, 2012, as a result of a competitive negotiated acquisition, a cost reimbursement fixed-fee Indefinite Quantity-Indefinite Delivery contract (NRC-HQ-12-C-04-0065) was awarded to Energy Research, Inc. of Rockville, MD. The contractor will support the NRC in developing a full-scope site Level 3 Probability Risk Assessment that assesses accidents involving one or more reactor cores as well as other site radiological sources (i.e., spent fuel pools and dry storage casks). The period of performance period is from June 1, 2012, to May 31, 2016, with no option periods. The total value of the contract is \$816,586.

Electrical and Electronics Engineers (IEEE) Meeting

On May 21 - 22, 2012, staff participated in the Institute of Electrical and Electronics Engineers (IEEE) Subcommittee 2 (Qualification of Equipment) meeting in Las Vegas, NV. During the meeting, the staff participated in several working groups related to qualification of electrical equipment. Specifically, the staff participated in working groups for IEEE Standard 323, "IEEE Standard for Qualifying Class 1E Equipment for Nuclear Power Generating Stations," IEEE Standard 344, "IEEE Recommended Practice for Seismic Qualification of Class 1E Equipment for Nuclear Power Generating Stations," and IEEE Standard 650, "IEEE Standard for Qualification for Class 1E Static Battery Chargers and Inverters for Nuclear Power Generating Stations." The staff also provided information on recent NRC-related activities associated with environmental qualification of electrical equipment (license amendment review issues, inspection issues, and Regulatory Guide update status) and Fukushima-related regulatory items (Advanced Notices of Proposed Rulemaking, Orders, etc).

Public Meeting on Near-Term Task Force (NTTF) Recommendation 8 Advanced Notice of Public Rulemaking (ANPR)

On May 23, 2012, the staff held a public meeting to discuss NTTF Recommendation 8 ANPR for onsite emergency response capabilities related to the Fukushima Daiichi nuclear power plant accident. This meeting provided an opportunity for the public and the staff to exchange information about the ANPR so stakeholders can provide more informed written comments while the ANPR is available for public comment.

Meeting with Canadian Nuclear Safety Commission

On May 27, 2012, the staff met at the Point Lepreau CANDU station with representatives of the Canadian Nuclear Safety Commission (CNSC), NB Power (the licensee), and Ontario Power to learn about the installed filtered containment venting system at the station. According to the CNSC and the licensee, planning for and installation of the system occurred before Fukushima on the basis of Level 2 probabilistic safety assessment and defense-in-depth. The staff shared information on the status of the work on filtered vents at Mark I and Mark II sites in the US. The information exchanged will be used in considering options involving the capability of the NTTF Recommendation 5.1, Reliable Hardened Vents as ordered in EA-12-50.

Issuance of the Renewed Operating License for Pilgrim Nuclear Power Station

On May 29, 2012, the operating license for the Pilgrim Nuclear Power Station was renewed, authorizing operation for an additional 20 years beyond the original license expiration date. The new expiration date is June 8, 2032. The staff completed its review as documented in the Safety Evaluation Report, NUREG-1891, published November 2007, and the Supplemental Environmental Impact Statement, NUREG-1437, Supplement 29, published July 2007. The staff also supplemented the Safety Evaluation Report in 2007 and 2011. The issuance of the Pilgrim Nuclear Power Station renewed license brings the total number of renewals to 73 reactor units.

Naval Reactors Briefing on FORD Class Aircraft Carrier Review

On May 30, 2012, staff conducted a site visit to Naval Reactors. The purpose of the visit was to receive a classified briefing related to the upcoming review of the FORD class aircraft carrier. The FORD safety analysis report is scheduled to be provided to the NRC in June 2012.
