The purpose of this letter is to provide information related to the construction schedule for VCSNS Units 2 and 3 in support of the NRC Region 2 Construction Inspection Program. This letter contains the periodic update of the VCSNS Units 2 and 3 project schedule provided on the enclosed compact disk (CD). The information is considered proprietary (i.e., a trade secret) to both Westinghouse Electric Company, LLC (Westinghouse) and Shaw, Stone, & Webster, Inc. and was determined to be treated as such by the NRC in reference 1. Accordingly, it is requested that the enclosed schedule information be withheld from public disclosure in accordance with 10CFR2.390.

The schedule information contained in the enclosed CD is proprietary in its entirety; therefore, a non-proprietary version is not provided. This information is dynamic in nature and should not be considered absolute. In addition, schedule information may contain dates for ITAAC closure letters; however, actual submittal dates are yet to be determined pending SCE&G review and approval.

At this time the Unit 3 schedule revisions, reflecting actual receipt of COL, have not yet been made and, as such, have been excluded from this submittal. Any details that remain in this publication related to Unit 3 should be disregarded.
