I am writing to request you to follow up on your correspondence to the Nuclear Regulatory Commission dated October 25<sup>th</sup> 2007. The interpretation of the public law you and Congressman Whitfield passed to ensure armed officers are used to protect the Paducah site continues to be a concern not only for present operations but for the future.

As of this moment there are significant activities on the DOE Reservation that are conducted without the protection of Protective Force Officers armed or unarmed and this in my opinion places national security, government property, personnel and the public at risk.
