Enclosed is Amendment No. 75 to your NRC Material License No. 13-18881-01 in accordance with your request. Please note that the major changes made to your license are printed in **bold font**.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

**This also refers to the change of ownership between Memorial Hospital (MH) of South Bend and Elkhart General Hospital (EGH), as described in your letter dated March 1, 2012.**

**We noted that your letter failed to provide the date when the change of ownership occurred. However, from our records for EGH, we were aware it had occurred on November 22, 2011.**

**In addition, NRC's written consent was not obtained prior to the change of ownership taking place.**

**Further, only your signature, as the Radiation Safety Officer, appears on the letter dated March 1, 2012.**

**In the future, please ensure that an appropriate management representative signs all correspondence with us.**
