Pursuant to a condition of Tracerco's License No. 07-28386-01 and 10 CFR 32.12, Tracerco is required to file an annual report regarding the transfer of byproduct materials in accordance with 10 CFR 32.11. Subsequently, a recent internal audit of Tracerco's radiation protection program it was discovered that the required annual report for 2011 had not been submitted. To correct this omission enclosed is the required report for 2011. All transfers were in compliance with a license condition authorizing Tracerco to introduce byproduct materials as contaminants in tracer studies and to transfer ownership and possession of the product or material containing byproduct material to persons exempt from the requirements for a license provided in 10 CFR 30.14. The concentrations of byproduct materials at the time of transfer did not exceed the concentrations in 10 CFR 30.70 nor were the products incorporated in any food, beverage, cosmetic, or other commodity or product designed for injection or inhalation by, or application to, a human being.
