Dear Mr. Dryden:

This refers to your letters dated March 29, 2012, and May 15, 2012, notifying the NRC of the transfer of ownership and control of License 21-20250-01 issued to Community Memorial Hospital, d/b/a Cheboygan Memorial Hospital.

The transferee should note their new responsibility and liability as an NRC licensee. Specifically, responsibility is emphasized with regard to any ongoing NRC inspection and enforcement issues, investigations, facility decontamination and decommissioning funding resources. Please be advised, change of ownership/control cannot be transferred without **prior** written consent from the NRC (10 CFR 30.34 (b)). 

Based upon the information submitted in your request, license number 21-20250-01 is hereby terminated, and the facility was added to McLaren Northern Michigan's NRC license 21-16732-01 by amendment 50.
