We have completed our review of your application to revise the license application, transmitted by letter dated March 20, 2012. Our review of your application has identified that additional information is needed before final action can be taken on your submittal.

Pending the additional information, which answers the Request for Additional Information, we anticipate completing our review by the end of August 2012. This date could change depending on the findings of our technical review, urgent assignments, or other factors. We will promptly communicate any significant changes to this schedule.
